Dear Parents:

Greetings from the Huntington University Cheerleading Squad. We are currently preparing for an exciting basketball season, but are beginning to make preparations for a team-sponsored event. Our 14-member squad will be hosting a cheer clinic on Saturday, Nov. 21st from 8:30 a.m. to 11:30 a.m. at the gymnasium. We are inviting girls between the ages of 5-14 to participate in the clinic at a cost of only \$25 per person.

If your daughter would like to attend the clinic, please complete the attached Registration Form and send it along with your payment of \$25. All checks should be made payable to Huntington University Cheerleading. To give us a better idea of who will be attending the clinic and ensure your daughter will receive a t-shirt, we request that you pre-register. However, we will allow participants to register at the door. Parents are welcome to stay and watch during the clinic.

We will also be inviting all participants back to the game that day where they will have the opportunity to demonstrate the cheer they learned from the clinic. Everyone does not have to participate but they are encouraged to do so. All participants will get in free of charge if they wear the t-shirt they received from the clinic.

Participant Agreement, Release, And Acknowledgement of Risk

In consideration of the services of Huntington University, their agents, owners, officers, volunteers, participants, employees, and all other persons or entities acting in any capacity on their behalf (hereinafter collectively referred to as "Huntington University"), I hereby agree to release and discharge Huntington University, on behalf of myself, my children, my parents, my heirs, assigns, personal representative and estate as follows:

1. I acknowledge that cheerleading activities entail known and unanticipated risks which could result in physical or emotional injury, paralysis, death, or damage to myself, to property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity.
2. I expressly agree and promise to accept and assume all of the risks existing in this activity. Participation in this activity is purely voluntary, and I elect to participate in spite of the risks.
3. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless Huntington University from any and all claims, demands, or causes of action, which are in any way connected with my participation in this activity or my use of Huntington University's equipment or facilities, **including any such Claims which allege negligent acts or omissions of Huntington University.**

By signing this document, I acknowledge that if my child is hurt during participation in this activity, I may be found by a court of law to have waived my right to maintain a lawsuit against Huntington University on the basis of any claim from which I have released them herein. I have had sufficient opportunity to read this entire document. I have read and understood it, and I agree to be bound by its terms.
