REV. L. B. PECK, M. D.

Rev. L. B. Peck, M. D., was born in New York, emigrated to Illinois in 1845, and died in Freeport, Dec. 23, 1896, aged 74 years. He grew to manhood in Green Co., N. Y., and was educated in the schools of that county. He studied medicine under Professors Foote and Swift, both of whom were noted physicians. Dr. Peck practiced his profession in Freeport (Ill.) and vicinity between thirty-five and forty years, and was well and widely known in all the Northwest. In 1843 he was married to Miss Elizabeth Wilcox. Five children were fruits of that marriage, of whom but two live. His first wife having preceded him to the spirit land, he was married to Mrs. Anna Eliza Loxeks at Albany, N. Y., May 20, 1859. During his twenty-third year he became deeply awakened on the subject of the Christian life, and was graciously saved. His conversion he never questioned. Shortly after he joined the Methodist Episcopal Church, and by it was soon licensed to preach the gospel. He honorably sustained this relation until 1861, when he transferred his membership to the Church of the United Brethren in Christ, receiving his quarterly-conference license Nov. 23, 1861, signed by James Johnson, presiding elder. The year following he was received into Rock River Conference, and by that body, on the 20th of September, 1862, was granted annual-conference license. Two years later, October, 1864, he was solemnly ordained to the office of an elder by the laying on of hands. His ordination papers were signed by Bishop J. Markwood. The early part of his ministry was very fruitful. He was pre-eminently an evangelist, strong, vigorous, and enthusiastic. His fiery words burned into the hearts of the unsaved until they were constrained to yield to the Spirit of God; and many hundreds will rise up at the last day and call him blessed. As a minister he was a good man, full of the Holy Ghost. As a physician he was kind, attentive, and successful. As a citizen he was honest and upright—"a manly man." As a Christian he was exemplary and modest. Among one of the last things he did for the glory of the Master was a large contribution for the erection of a temple for the worship of God—the same church in which his funeral services were held. As a friend he was true and faithful. As a husband and father he was kind and loving. The home was only made the brighter and happier because of his presence. He leaves behind to mourn his death a faithful, loving wife, two sons, one step-daughter (to whom he was greatly attached), three brothers and a sister, a large number of relatives, and a host of friends.
